The tender stated that "The Vehicles deployed must be of 2021 year model on the date of deployment".  In this regard, it is submitted that 15 days is considered too less a time for making the vehicles mobilized considering that the vehicles requisitioned should be of 2021 Model. We request to enhance the mobilization period for deployment of vehicles to minimum 30 days. W	Agreed, Modified the Mobilization period shall be 30 days

9.	The Contractor shall to pay all charges/Taxes, like, Permit Charges, Road Tax, Octroi, Toll Tax/charges, Parking Charges, etc. for movement of vehicles within the state, which are included in the quote.	The charges stated to be included cannot be Foreseen at the time of submission of bid because there are umpteen factors that are involved say the frequency of visits, the place of parking etc. The Toll tax too varies on how many visits are being made to different places depending upon operational requirements. This is a three year contract. You will appreciate that this cost cannot be foreseen and hence is not possible to be included in a quote. The general understanding in these type of tenders is payment against documentary evidence. We have been doing business with entities like ONGC, BSNL & GAIL and all these companies prescribe provision of payment of such type of taxes / levies at actuals upon submission of documentary evidence.  Being a genuine concern, we request for modification of the clause, in line with the explanation submitted above.	
10.	Value of Security Deposit	The Security Deposit stipulated in the tender is "3% of Annualized contract" whereas as per the Government of Andhra Pradesh Order no. "Rt. No. 266 dated 15.02.2021".
